David “Murdock” Riesenberg, 49 of Halbur, died Saturday, April 2, 2016 from injuries received in an automobile accident near Roselle.

Funeral services will be held at 2 p.m., Thursday, April 7, 2016 at the Sharp Funeral Home in Carroll, with Fr. Timothy Johnson officiating. Born on June 12, 1966 at Carroll, Iowa, David was the son of Alvin and Donna (Meister) Riesenberg. He grew up in the Roselle area and attended Holy Angels School, before graduating from Kuemper Catholic High School in 1984. After his schooling he worked for Riesenberg Construction. He then worked for a brief time for R.L. Kraft Roofing in Denison where he was given

the nickname Murdock – a name he received for his tenacious work ethic. David then went to work for Naberhaus Implement, where he worked for nearly 30 years. During those years he was known for his “MacGyver” ability to fix anything that was brought to him.

On April 26, 2014 on their farm, David was united in marriage to Carol Porter. In his spare time David enjoyed fishing, camping, working on his acreage, gardening, and canning. In his earlier years David enjoyed golfing and hunting. Most of all he enjoyed his friends, and family especially his grandchildren.

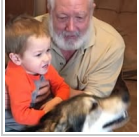
